jury foreman. Stacked - illegal jury. Then Ovard  
Falsified the states evidence "Diary" and pretend  
to put it on the courts records - its not on the courts  
records - it doesn't exist. My P.D. filed a full alibi  
showing I had not been in Texas 3 years prior of  
after Falsified assault. 12-31-96. Ovard struck it  
from the record and Barred it from trial. During

trial public defender investigator acquired the grand jury records F0500065 and my Fed. NCIC records showing Kidnapping - falsified indictment. Filed motion to dismiss - Ovard had courts clerks steal the grand jury and NCIC records evidence off the courts - co clerks and DAs records. Stole the motion. I demanded P.D. reacquire the stolen records and refile motion. When he tried Ovard ordered him into his chambers for a private meeting of star chamber. Upon returning my P.D. said I will not reacquire the stolen records or motions Ovard threatened my career. Then my P.D. told the jury I was guilty. Life sentence. Ovard ordered the Oregon case is under appeal and not a final conviction and will Not be used in F0500065. Then allowed the Watson crime family - an Oregon forest ranger - Oregon prison staff to testify about Oregon illegally. Ovard then had the trial transcripts deleted and rewritten to say things Not said during testimony. Now the recorded disk is being withheld. Ovard then called in favors from appeals judges to deny me appeals. All denied without grounds - then illegally affirmed  
without an appeal. 6-2254 Fed appeals - all  
denied without grounds - then illegally affirmed  
without an appeal. 16 state civil suits filed  
Dallas Co. - All thrown away unfiled. 6 requests  
motions 5<sup>th</sup> CT APP. to order Dallas Co to file  
my civil suits - all denied - 4 motions Texas  
state supreme court - to order the 5<sup>th</sup> CT APP  
to order Dallas Co to file my civil suits - all denied.  
18 Federal civil suits all denied without  
grounds. All courts records FC500065 and  
05-C8-01049 are being withheld - US Court of  
Appeals changed my courts fees from \$1306,00  
to \$505,00 - then Barred me from complaints;  
Judicial misconducts. Saying trying to acquire  
courts records FC500065 and filing capitol  
and Felony crimes against Judges is frivolous  
and malicious and will not be allowed.

I Am innocent!!! And the  
withheld court records prove  
it.
