TODD JOHNSTON FROM THE MICHIGAN STATE POLICE POST # 81 TAMPERING WITH DNA EVIDENCE IN MY CASE DOCKET NO. 12-50218-FH ON JUNE 16, 2011 ABOUT EXTORTION OF A CORRECTIONAL EMPLOYEE NAME GAIL O'BELL WHO THEY WERE SECRETLY INVESTIGATING ALONG WITH TODD EDWARD SAURO ANOTHER CORRECTIONAL EMPLOYEE INCLUDING JOHNNY KANGAS WHO'S SON WAS IN MY JURY POOL IN FRONT OF HON. THOMAS ~~BRONKA~~ AND MY ATTORNEY TIMOTHY QUINELL AT TRIAL WAS AWARE OF IT AS WELL AS MY DISTRICT COURT JUDGE HON. ROGER KANGAS WHO WAS ALSO AWARE OF IT CAUSE HIS DAUGHTER AMY KANGAS WAS PART OF THE SECRET INVESTIGATIONS THAT INVOLVED MULTIPLE CORRECTIONAL EMPLOYEES FROM MARQUETTE BRANCH PRISON, BARAGA MAXIMUM CORRECTIONAL FACILITY, ALGER CORRECTIONAL FACILITY AND THE OLD KINKROSS CORRECTIONAL FACILITY, INVESTIGATIONS THAT STARTED IN 2010 INTO 2013 THAT I WAS THRUST INTO CAUSE ONE OF THEIR CORRECTIONAL STAFF LIED TO GET OUT OF AN INVESTIGATION AFTER CATCHING WIND OF IT AFTER HER P.O. BOX IS IN LITTLE LAKE, MICHIGAN AND ADDRESS ON STRATAFORD LAKE ROAD WAS FOUND IN 3 PRISONERS CELLS NAME MAURICE MOORE, GARFIELD LAWSON AND AARON BAKER, AND WHEN I REFUSED TO PLAY A PART IN THEIR DECEPTIVE ACTS TO SNARE THEM

MEANING REFUSING TO BE A SNITCH I WAS TRANSFERRED FROM MARQUETTE BRANCH PRISON AFTER BEING PLACED IN SEGREGATION BY THEIR INSPECTOR LINCOLN MARSHALL AT THE TIME IN MAY OF 2011 AND I WAS SENT ON UP TO BARAGA MAXIMUM CORRECTIONAL FACILITY WHERE I WAS SNUCK OUT OF THE PRISON JUST LIKE AT MARQUETTE BRANCH TOOK OUT ON EXPEDITIONS IN ORDER TO SCARE AND SQUEEZE ME OFF WHICH I NEVER BUDGED ONE BIT AND THAT MADE THEM MAD ENOUGH TO STAGE FORENSIC EVIDENCE AFTER CLEARING MY TYPEWRITER IN A POLICE REPORT OF THE STATE POLICE OF CREATING THE INFAMOUS EXTORTION LETTER 2 OF THEM FOR \$10,000.00 AND THEY EVEN WENT FURTHER ON JUNE 16, 2011 KNOWING MY DATA HAS BEEN IN THE COOL'S DATA BASE SINCE 2003, THEY BROKE THE LAW AND CAME AND RETRIEVED IT AGAIN 8 BUCCAL SWABS AND HEATHER GORF-CHARTY, JAY PETERSON, JENNIFER PATCHIN ALL ACTED IN CONCERT TO DECEIVE THE COURT ABOUT CHAIN OF CUSTODY FROM THE FOLLOWING MICHIGAN STATE POLICE FORENSIC LABS IN GRAYLING, MARQUETTE, BRIDGEPORT INCLUDING THE ONE IN LAWSONING THAT TOOK OVER THE DETROIT CITY FORENSIC LAB AND I SAY THAT TO SAY IN A COURT OF LAW THE FORENSIC LABS ADMIT THEY RECEIVED ONLY 4 SINGLE TIP APPLICATOR BUCCAL SWABS FROM THE DETECTIVE AND HE ADMITS HE USED (2) 2 SIDED Q-TIPS ALSO WHICH HE SAID EQUALS 8 4 ADDED WITH THE 4 SINGLE TIP ONES THE FORENSIC LAB ONLY RECEIVED AND I SAY THIS TO SAY ON COURT RECORD IN COURT UNDER OATH IT WAS SAID MY DNA WAS FOUND ON BOTH ENVELOPE'S SEALS, NOW HOW IS THAT POSSIBLE WHEN THE ~~IR~~ WITNESS LINCOLN MARSHALL GETS BACK ON THE STAND AFTER HEARING GAIL AND OREN TESTIFY AND HE STATES HE CREATED THE SECOND ENVELOPE THEY FOUND MY DNA ON (20)

NOW IN THE DETECTIVE'S OWN POLICE REPORT FILE WITH THE MICHIGAN STATE POLICE IT CLEARLY STATES THE FORENSIC LAB ONLY TOOK TWO PORTIONS FROM ONLY ONE ENVELOPE FLAP AND THE DETECTIVE TOLD ME PERSONALLY HE USED A GRY MOUTH LIQUID CALLED BIOTONE TO GET MY DNA ON BOTH OF THESE ENVELOPES WITH THE FORENSIC LAB, MY RIGHT THUMB PRINT WAS FOUND ON ONE ENVELOPE CONSISTANT WITH WHAT I SAID LINCOLN MARSHALL SHOWED THEM TO ME DURING THE INVESTIGATION. THEY SAID I CREATED THEM USING TYPING PAPER, BUT IF THAT WAS THE CASE HOW IS IT NO OTHER FINGER PRINTS OF PRISONERS WERE FOUND, BUT IT WAS MULTIPLE CORRECTIONAL EMPLOYEES FINGER PRINTS ON BOTH SIDES OF THE ENVELOPES AND LETTERS, THAN AT TRIAL LT. DET. TODD JOHNSTON STATES HE NEVER ONCE SPEN THE SWINTEE TYPEWRITER I OWNED FURTHER STATING HE TURNED THE CHAIN OF CUSTODY INTO THE MICHIGAN STATE POLICE FORENSIC LAB WHICH ARE THE EXTORTION LETTERS ON JUNE 16, 2011, BUT AFTER MANY TAUNTS FROM HIM AND PROSECUTOR ANDREW GRIFFIN WHO'S NOW A JUDGE WHO TOLD ME REPEATLY IN THE COURT HALLWAYS MY ATTORNEY S SCOTT BROGAN, KEVIN BRANSON AND TRIAL ATTORNEY TIMOTHY QUINN WEL HAD SOLD ME OUT SHOWING ME DOCUMENTS THAT EXPOSED THEIR WITNESSES WERE LYING UNDER OATH AND I WAS BEING DENIED THESE DOCUMENTS DURING DISCOVERY THAT I EVENTUALLY OBTAINED AFTER SUTONCING FROM JOHNNY KANGAS A CORRECTIONAL OFFICER WHO WAS IN THESE INVESTIGATIONS WHO'S SON KEITH KANGAS WAS IN MY JURY AS A JUROR, SO I WROTE MY ATTORNEY UP THROUGH THE ATTORNEY GRIEVANCE COMMISSION WHO SENT ME THE SAME REPORT THEY ENDED UP GETTING FROM TIMOTHY QUINN WEL
