11-23-2003 2315 hr. Sergeant Tallman, 4194, contacted Detectives' Suguro and Weklych regarding a possible homicide at their respective homes. Detectives' Suguro and Weklych responded as the Stand-By detectives. Detectives' Suguro and Weklych were directed to respond to Discovery Park where the victim's body was dumped in the park. A witness was with East Precinct patrol officers and was going to show the officers where the body was located within the park.

11-24-2003 0005 hr. Detectives' Suguro and Weklych arrive at Discovery Park at the W. Emerson entrance. Sgt. Tallman is present with several patrol officers from the East Precinct. Also present is Demar RHOME, black male, date of birth 7-16-83. Rhome has taken the officers to the location of the body. The body is west of the gate on W. Emerson among the trees and bushes several yards north of the fence along W. Emerson. The body is wrapped with sheets and blankets that are all inside of black plastic garbage bags. The ground is damp with the skies clear.

11-24-2003 0010 hr. The following information is given by Officers' Bretton and Sundin: Beverly BROWN, 360 885-2271, called Seattle Police Communications on 11-23-2003 at 2136 hr. Beverly Brown states her daughter's (Kialani Brown) boyfriend (Demar Rhome) called her two days ago and said her daughter stabbed his ex-girlfriend two days ago. The suspect's boyfriend says he has the knife used to stab victim and knows where the body is stashed. Officers responded to 2302 E. Pine. Beverly said Kialani has a young child that she gave to Beverly's sister (Kialani's aunt) within the past hour. Officers stopped Rhome and Kialani as they were walking away from 2302 E. Pine. Rhome and Kialani were advised of their Miranda Rights, including the juvenile warning to Kialani. Rhome said Kialani and he went to 2317 E. Alder to meet the victim, Lashonda FLYNN. Rhome admitted there was a history of domestic violence between Flynn and himself. Rhome said Kialani and Flynn got into a fight. The fight was over Rhome going to California with Kialani. Rhome said Flynn pulled out a knife. Kialani pulled out a pocketknife from her back pocket and stabbed Flynn several times. Rhome said it took a little while for Flynn to die. Rhome said he assisted Kialani in wrapping up Flynn in a blanket. Kialani called a taxi. Rhome and Kialani put Flynn into the taxi and they went to Discovery Park. Rhome said he helped Kialani drag Flynn to the edge of the path. Kialani then drabbed the victim into the woods by herself. Rhome showed the officers where the body was. Rhome said the clothing Kialani and Flynn were wearing during the assault were at 2302 E. Pine.

11-24-2003 0030 hr. Sgt. Tallman summons patrol officers to maintain security on the outside and inside of the fence along W. Emerson. The officers will be posted to protect the crime scene.

a dating relationship, which formerly ended on Oct-09-03. In August of 2003, they began to speak again. However, S/ Anderson began to dislike him and would make threats to have V/ Demar assaulted by some of her friends. She began making several phone calls to his home and when he would answer, she would put him on the speaker so all her friends could listen to him. V/ Demar eventually began to hang up whenever she called and got to the point where he would not answer the phone. When he did this, S/ Anderson would leave messages saying that she would get him in trouble.

On 11-04-03 at 2130hrs, V/ Demar found one message on his phone from S/ Clara and four from S/ Anderson, stating that they were going to the Lynwood Police Department to file an allegation of Statutory Rape against him. They also left messages that they would have S/ Demar assaulted and would gloat on the messages as they were going to carry this out.

V/ Demar felt threaten by the threats and by the allegations of sexual and the possibility of his freedom being taken away. As of this date and time, V/ Demar has not heard from the Lynwood Police Department. Ofc. Hoter listened to V/ Demar's voicemail recordings, one from S/ Clara and four from S/ Anderson.

Call #1: 11-04-03 at 1520hrs was from S/ Clara who made vague comments about getting V/ Rhome in trouble and hung up.

Call #2: 11-04-03 at 1543hrs was from S/ Anderson who made comments about going to the Police to file attempted rape charges that he committed with her best friend.

Call #3: 11-04-03 at 1544hrs was from S/ Anderson who repeated her threats about going to the Police and that he was in trouble.

Call #4: 11-04-03 at 1546hrs was from S/ Anderson who threatened to have V/ Rhome assaulted by gang members that she knew that lived in the Central District and mentioned filing rape charges against him.

Call #5: 11-04-03 at 1804hrs was from S/ Anderson who threaten V/ Rhome again, but hung up.

According to Ofc. Hoter, she heard what sounded like girls giggling and sounded as if they were gloating an egging the other girls on during the recordings. Ofc. Hoter obtained a written statement from V/ Rhome and gave him a DV Pamphlet and a business with a SPD case number.
