Hello my name is Destiny Rebecca Somersall I was just sentenced October 30th 2023 in Martinsburg West Virginia Federal Courts to a 40 year sentence in one account of sex trafficking. I've been completely cooptive with the FBI from the day they started there investigation. I was a victim my self starting at 1 yrs old and was evaluated by a forensic physcatrist saying my mental health goes back a long way on paper since 1995. Most of all the things is lies said about me. Judge Gina Groh was the sentencing judge and The prosecuting attorney was Kimberly crockett which ask for 40 yrs I've been out of trouble since 2003 other than driving valations. There is others involved also in Hagerstown Maryland I have papers of some of the things they were doing they just pled guilty to charges and is only facing 1-15 yrs

Before this charge I was a mother single taking care of my child not in trouble and for them to hand me down such a harsh sentence is outrageous and completely insane and unfair. There is another woman

whom Kimberly Crockett has made take a 15 to 40 yr sentence and she's under hole different circumstances.

My lawyer first came to me with this plea from Kim Crockett and when I said I was refusing it Kim Crockett told me she would get me 3 Life Sentences if I didn't agree with her plea my public defender advised me to take her plea. I truly believe this hole entire year my legal counsel has been not for the best interest of me. I am Kim Crockett also told another person if she wouldn't accept her plea she would see her get Life or the death penalty. Its is a routine of hers and her pleas of 15 to 40 is too.

As I've said I completely cooperated with FBI and Kim Crockett and she just used everything to help her case and down me After my sentencing a FBI Marshal told me to my face it didn't matter what I said or did Gina Groh the Judge new she was giving me before I showed up in the court house that day. That her Judge Gina Groh and Kim Crockett are friends outside of their jobs and Judge Gina Groh sides with Kim Crockett all the time. I have
