

MY NAME IS STEVEN LEE KEMPLE I WAS CONVICTED OF A
CRIME THAT NEVER HAPPENED 36 YRS AGO. CASE BEGAN IN 1985
WHEN MY WIFE WAS RAPED AND BEATEN BY TWO CITY JAILERS
IN COLTON, CHRISTI, TX. A LAWSUIT WAS FILED BY FAMILY LAWYERS
LATER WAS TOLD THE DA. WANTED TO SETTLE OUT OF COURT
\$30,000⁰⁰ WE REFUSED. AS MONTHS WENT BY WE WERE HARASSED
BY SGT. ROBERT DELA CARRA AND FRIEND ERIC LOSTER THAT I
HAD A "HIT" PLACED ON ME. ME, MY WIFE AND KIDS HAD TO
MOVE A FEW TIMES. ANOTHER CASE BEGAN JAN 23, 1986 JESSE
SANDLATE (VICTIM J.S.) 8 YR OLD AND HIS BROTHER ROBERT SANDLATE
(R.S.) 13 YR OLD STAYED AT HOME WHILE THEIR MUM WENT TO
HER STORE. J.S. CLAIMED (TESTIFIED) HE WAS SITTING ON HIS FRONT
PORCH NEXT TO THE FRONT DEVE WITH IT OPENED AND HIS
BIG BROTHER (R.S.) SITTING INSIDE NEXT TO THE DEVE WHEN A
MAN WALKED UP AND SAID COME HERE. THEN GRABBED
HIM AND DROPPED HIM NEXT DEVE. BUT HE NEVER FELLED
FOR HIS BROTHER. THIS WAS ON A VERY BUSY STREET AT 1 PM
A SMALL SCHOOL ON THE CORNER GAS STATION AND A LAUNDRY
MAT ON THE OTHER SIDE 2 HOUSES DOWN. PAST HALF A BLOCK
AWAY. J.S. CLAIMS HE WAS TAKEN TO THE HOUSE NEXT DOOR
AND THE MAN RAPED HIM 20 TIMES THROUGHOUT THE NIGHT,
AND LOCKED HIM IN THE CLOSET. THE NEXT DAY HE KICKED
THE DOOR OPEN (TAM) AND WALKED HOME. THE MOTHER
TESTIFIED SHE LEFT THE BOYS AT HOME 12 noon RETURNED HOME
AT 2:30 PM NOTICE THE BOYS COULDN'T COME HOME AT 7 AM TAM
WAS ASKED WHERE J.S. WAS SAID DONT KNOW! MUM CALLED
POLICE. AT 10 PM NEWS REPORTER (FILM BOTH HOUSES) MUM STAYED
IN HOUSE BUT MOTHER CALLED THAT HER EX HUSBAND JESSE
BOWMAN HAS HIM THEY LEAVE AT 10:45 PM. JAN 24, 1986
AT 7 AM MUM CALLS POLICE SAID HER HOME. SHE SAID (TESTIFIED)
HE WAS CLEAN, NOW HE HAS MUD IN HIS HAIR, ARMS,
TENNIS SHOES, KINGS OF PANTS, IT WAS ALL OVER HIM. AT 7:20
POLICE SHOW UP AND TAKE HIM TO HOSPITAL WHEN HE TOLD THEM
HE WAS RAPED 20 TIMES. J.S. GAVE A DESCRIPTION OF A MAN HE
CLAIMED HE NEVER SAW BEFORE. THE VACANT HOUSE WAS 10:45 PM
STAYED OUT ON THIS DAY, I WAS AT HOME MAKING CALLS TO
TO CONTRACT I HAD LINED UP A FEW DAYS BEFORE ONE WAS
TWO BLOCKS AWAY. WHEN JOHN COULD NOT COME TO PHONE I
TOLD THE LADY I WAS ON MY WAY OUT. AS I GOT A BLOCK AWAY

I noticed A Vacant Home with the Doors OPEN I SAW
A For Rent Sign I took out my Little Note Pad and
wrote down the # that it related to. As I
walked and entered I was arrested. I was questioned
on what I was doing, where I was living, and where
I lived. I showed the 2 Detectives my Business card
and explained my type of work. Officers came back said
he was on his way there and talk to my wife at the house.
I heard them say I did not match the description, then
they let me go. As I was leaving SGT GARZA Pulled up
saw me and tells them to take me to the Hospital
where J.S. was asked at least 8 times was I the man
J.S. said no! SGT GARZA then car door told me to get
out, then knee down to J.S. Again He said "NO"
We caught the man inside the house looking in the closet
where you was in this the man J.S. said no. I got mad
we started to argue they went back into the Hospital
as I watched for 45 min through the Glass at Hospital
then I was put back in car and taken to city Jail
(11.45 AM). I was incarcerated for two days. the 1st day
by a lady detective she talked me out of a Request for an
Attorney by telling me "ONLY Guilty People need Lawyers"
she also told me if I give her a hand written statement
where I was all day on the 23rd and a map showing
the Route I took, she would check it out. She went to
my house took clothes, shoes, etc. The 3rd day I was
given clothes and taken to another Jail. As I stepped
outside I realized a Simple Arrest had turned into
a ~~total~~ scheme. I was humiliated throughout the
the media for months. I was broadcasted throughout the
the state on TV and Radio this ridiculous crime that
never happened as "GOD IS my witness". A week later
I was charged for AGE Sexual Assault + AGE Kidnapping,
a Doctor testified there was no sexual Assault. (Case
dropped) by SGT GARZA knew this at the Hospital at 12 noon
I was booked in at 12 noon. SGT GARZA called the
Forensic team back to the vacant house at 12:15 am but
did not show up until 1:30 pm to meet with SGT GARZA.

set back testimony shows) Reports show JS gave a identification
to police at 9:30 AM Jan 24 1986 of a man that abducted
him. Man was in his late 30's, had tattoos on arm, his teeth
in the front was yellowish and bent inward. I was 24 yrs old
My teeth are not yellowish or bent inward. JS was asked by Det-
-ictives, Policemen, Mother, Doctor (testimony shows) if he knew
or seen the man before that abducted him. JS said "NO"
At trial he said 3 different times He knows me, but no one
followed up on it. The Judge, Prosecutor and appointed lawyer
knew and should of decided the victim was lying and if
a liar should be trusted but the system achieved permanen-
cy by incentivizing coercing this witness on lying all thro-
ugh trial. IN addition the Detective, Policemen, Judge, Prosecutor
and appointed lawyer had NO incentive in telling the truth be-
cause they was so deep into the matter they can lose their job
and face prosecution. They all had to commit to "THE LIE!"
The crime never happen period, they will not caught lying
Against each other. JS testified man had long sleeves on
and never took off his shirt and remember when a tattoo said LOVE
but it did not show that word. The tattoo was on my shoulder Detective
summary report tattoos on arm (not shoulder) Detective testified tattoo
was faded out and had to ask what it said. I knew I was being
set up and told that lawyer to ask him who told him about my
tattoo (.) The lawyer asked him and the victim pointed his
finger at the prosecutor. Then the prosecutor asked him Did
I tell you the tattoo said LOVE JS said yes for victim (JS)
further testified he was in the DA's office and went over the
hole testimony of what he was going to say. The appointed
lawyer you would not believe what he told the kid. When it
was my turn to take the stand. The prosecutor question me
why was I at the house. Explain Kemple (old) homes for a
living and was looking forward on another house. I wrote
down the phone # off the for rent sign and address and
needed repairs on a small tabett. The prosecutor turned to
the jury and said said "Kemple is lying about a small tabett
said it 3 more times to the jury that Kemple is lying and the
DA's office would NOT hide this evidence when Kemple
was sent to prison. The Property Room gave Kemple his property
which was the little tabett and Kemple (1986) IN late of 1999
Kemple filed a open records Act when Kemple recieved

his documents one caught his eye. It was a inventory paper slipped from the City Jail (Jan 24 1986) showing the little tabella pencil when it further stated signed by a Judge Kempe did not know it was any good. Kempe study the law for 36y's. This case is the definition of the Brady Rules Requires prosecutors to disclose exculpatory evidence to the defense. Exculpatory evidence is evidence that can help the defense and they withheld exculpatory evidence on purpose to get a conviction in a high profile case cause of a civil suite filed against the DA office (02:CV) from two city Jailors Raping my wife. It appears Kempe was deliberately and wrongfully convicted through Acts of Prosecutor misconduct. The Prosecutor was able to convince the Jury Kempe was a liar. This can sit it out a denial of fundamental fairness, and shocking to the universal sense of Justice 316 US 462. When I was arrested at that house a police officer was testifying about what the two boys said (I was on my way over) the Prosecutor cut his testimony off. My pointed lawyer knew this from a hand written statement from me. He should of stop trial and interviewed my alibi witnesses. EVEN A Affidavit would of helped. The c/s failure to conduct an adequate pretrial investigation is why I am in prison. JS mom testified she knew me cause me & my wife & kids pass by her home all the time. JS told the court he knew me but told EVERY body else he did not know the guy that abducted him. The DA told me he was going to win his 1st case and I happen to be that #1. The difficulty of slavery issues relative to the capabilities of a lay litiganting would make it impossible for Kempe to obtain any sort of Justice without the aid of a lawyer and cannot procure a lawyer on his own.
