

my name is Hans Thomas, I have been wrongly convicted of a felony murder since 2002. I was convicted by a jury trial in the Frank Murphy Hall of Injustice, 1441 St. Antoine, Detroit, Michigan 48226.

This is my story of the BAD JURISTS, in my case as follows:

On or about September 16, 2003, Van Buren Township Police Department Detectives Michael Moening & Kenneth Floro went to the Wayne County Jail and took statement from codefendant Lamar Q. Roberts.

On or about September 17, 2003, during jury selection, Roberts is going to take a plea. Myself and codefendant Timothy Shepard are taken out of the courtroom and Roberts remains.

Roberts takes the stands and testifies, stating that he made a police statement the day before and today he wanted to except the states deal and testify for them. Roberts testifies that I had nothing to do with the shooting death of the victim, and he lied to his friend Jerry Bigham who testified to what he was told by Roberts at the first trial. The statement came in under 804(b)(3).

Trial Judge Vera Massey Jones P. 15595, does not except the plea and the second trial starts.

My trial attorney Ronnie M. Strong P34545, enclosed two of my alibi witnesses and did not call them to testify because he said he lost their contact information and forgot about them.

At the close of the APA William A. Rollstein P. 40771, proofs, Roberts wants to take the stand in his own defense. Since the trial judge already hear Roberts plea hearing testimony exonerating me of the homicide, she severed the trial at

Shepard and I from that of Roberts. Roberts was taken out of the courtroom and Shepard and I remained. Did closing arguments, the verdicts were sealed and we left the courtroom. Roberts came in and took the stand and testified that I had nothing to do with the homicide. I was not with him or Shepard before the homicide, during the homicide or after at the scene.

Roberts states that Sherryfield Abercrombie was shot twice in the head at the Comfort Inn Hotel parking lot at 45945 South I-94 Service Drive, Belleville, Michigan 48111, then his body was driven to his apartment several miles away at: Southport Apartments 10591 Oaklane, Bellemill, Michigan 48111, in the parking lot adjacent to building 17.

According to Roberts I show up at the apartment parking lot approximately 30 minutes after the homicide at this location.

I did not know anything about Roberts police before the start of trial, I also did not know anything about Roberts plea hearing testimony before the start of trial, because APA Rollstin suppressed it.

APA Rollstin also suppressed an agreement between Bigham and the VBTPD, to testify for them. The VBTPD, helped Bigham get three cases dismissed in Washtenaw County for his testimony in Wayne County. Bigham has bragged about this to several people.

Nothing that does not seem legal is the fact that Judge Jones heard Roberts testify that I had nothing to do with the shooting death of Abercrombie, then deny the jury from hearing evidence before their deliberation on the elements of the charges. How can this be legal? It seems like Fraud Upon the Court?

So here you have my Bad Jurists and the games that are played with years off of ones life. These type of people will always mess over other people as long as no one is looking. All eyes on deck, either we will swim in Success or we will drown in Failure.
