WHEREUPON, the Defendant being before the Bar of this Court and showing no reason why the sentence of the Court should not be pronounced, IT IS CONSIDERED, ORDERED AND ADJUDGED BY THE COURT that you, Ferry Lee Battle the Defendant in the above-stated case, be taken from the Bar of this Court to jail of said County, where you shall be safely kept until demanded by a guard to be sent from the Penitentiary of this State for the purpose of conveying you to said Penitentiary, to whom you shall be delivered, and by such guard you shall be safely conveyed to the Penitentiary of this State, or such other place or places as the Office of Offender Rehabilitation - Board of Corrections of the State of Georgia may direct, and be punished by confinement and labor in said Penitentiary, or other place or places as may be directed as aforesaid, for not less than the remainder of your natural life.

IT IS FURTHER ORDERED, That the Clerk of this Court notify the Office of Offender Rehabilitation - Board of Corrections of the State of Georgia of your conviction and sentence as required by law.
