
Enclosed is my complaint and our e-mails about posting my complaint against Judge Richard A. Schell.

My former attorney Brook A. Busbee, AUSA Andrew Milton Stover, and Judge Richard A. Schell all colluded to cover up the police torture by (1) refusing to allow me to get a medical examination of my police-torture injuries even after I said I could pay for all expenses myself, (2) falsifying documents to further cover up the police torture including getting the hospitals to hide the injuries and the Plano police to lie about their not finding evidence even though my medical records are replete with police abuse, (3) wrongfully denying my motions for a medical examination with false reasons and palliating with excuses to violate my due-process rights, (4) and so forth and so on, ad nauseam.

For over 11 years, my former criminal attorneys (6 of them!), two AUSAs, two magistrate judges, and two district judges all teamed up to cover up my police torture, because I'm just one hapless, abject prisoner stuck in a cell with no one to help me. And I have the severe, permanent injuries to prove it all! By way of example, I've had two former medical doctors--Dr. Fuhai Li and Dr. Martin Escobar--both confirm that my police-torture injuries (vein/tissues necroses from caustic chemicals injected through IV lines at Parkland Hospital) look totally different and are completely different from the small-circular-shrapnel, blast-accident injuries that put me in the hospital in the first place. Dr. Fuhai Li and Dr. Martin Escobar even confirmed that I can get a venous Doppler ultrasound and/or advanced imaging at any time, because my police-torture injuries are permanent.

With your help, I want the whole world to know that the United States tortures its own citizens, not just at Guantanamo Bay. Together, we can expose the United States of Torture. Let's be a part of something big. . . .

ok I figured out why I couldnt find it. The CTU deleted it. Therefore you can say Central Office. They also said since they did this this will probably be banned national pretty soon.

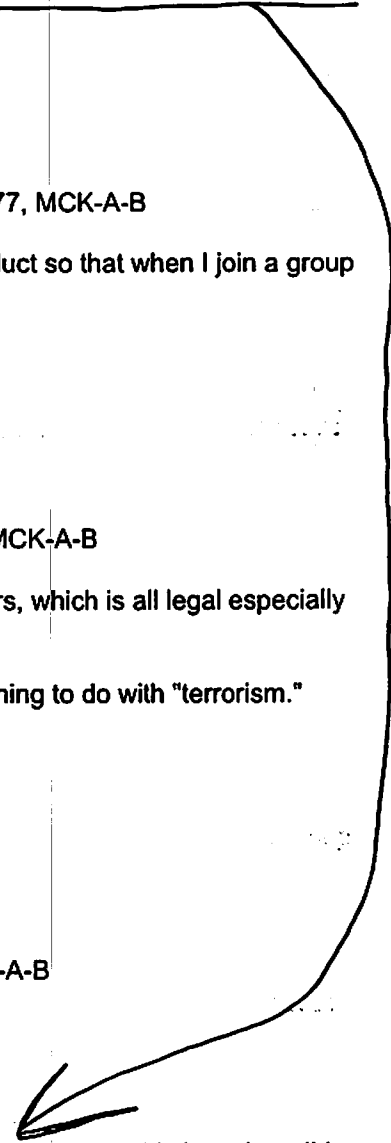

Is S.I.S. intentionally preventing info@BadJurist.com from accepting my request? I have to change my mind and file a grievance on this, because this is unacceptable in toto. I've done nothing wrong in this instance. I do not appreciate S.I.S.'s continuing interference with my e-mails. I've already filed grievances in the past against S.I.S. for stopping my e-mails, tampering with my regular mail, etc. I'm extremely choleric about this.

Mr. LaBenne, you've done nothing wrong, either, so I apologize for this.

I'm just sick and tired of S.I.S. engaging in puerile, dilatory, and ignominious acts of egregious misconduct. The last 5 incident reports written by S.I.S. Technician B. Weseman and S.I.S. Technician Peggy Sproveri against me have all been thrown out and expunged by the DHO AND UDC. That tells you that S.I.S. is retaliating against me.
